AQUALAB laboratory is accredited by the Portuguese Accreditation Institute (IPAC), under the NP EN ISO/ IEC 17025 (Technical Annexe L0417-1) standard, for the collection and testing of different water matrices, as well as for the testing of food products and the hygienic/sanitary monitoring of food handlers, surfaces and utensils.

Is your water suitable for human consumption? Is your swimming pool water safe?

Even when it looks nice and clean, water may contain chemical and microbiological parameters with values higher than those allowed by law and may not be suitable for human consumption or recreational uses.

Often, proximity between the catchment (boreholes, wells, lakes, etc.) and agricultural areas or septic tanks increases the likelihood of water contamination, which is why it is so important to carry out quality-control checks on the water from time to time.
